Scope:

This Policy applies to customer information Stone Mountain Pecan Company Co., Inc. collects through our website.

Website Privacy Policy:

Throughout this Policy the terms “SMPC”, “Stone Mountain Pecan Company”, “we”, “us” and “our” shall mean Stone Mountain Pecan Company Co., Inc. and any affiliates. This Privacy Policy applies to this site, www.stonemountainpecan.com, (however accessed and/or used, whether via personal computers, mobile devices or otherwise (collectively, “Device”) and other interactive features, applications or downloads that are operated by us that are available through this site or that interact with this site and post this Privacy Policy (collectively, “Website”).

Stone Mountain Pecan Company is committed to protecting the privacy of visitors to our website. This Policy will let you know how Stone Mountain Pecan Company handles how we collect, use, disclose, transfer and store your information collected on this website. Please take a moment to familiarize yourself with our privacy practices and let us know if you have any questions.

This Privacy Policy, together with the Terms of Use posted on our Website, sets forth the general rules and policies governing your use of our Website. We may update this Privacy Policy from time to time. When we change the policy in a material way, a notice will be posted on our Website along with the updated Privacy Policy. WHEN YOU ACCESS OUR WEBSITE, YOU ARE ACKNOWLEDGING AND ACCEPTING THIS PRIVACY POLICY. YOUR CONTINUED USE OF THIS WEBSITE AFTER CHANGES HAVE BEEN POSTED TO THE PRIVACY POLICY WILL CONSTITUTE YOUR ACCEPTANCE OF SUCH CHANGES. IF YOU DO NOT AGREE TO THIS PRIVACY POLICY, OR TO ANY CHANGES WE MAY SUBSEQUENTLY MAKE, IMMEDIATELY STOP ACCESSING OUR WEBSITE.

Collection and Use of Personal Information

We do not collect any information that allows us to identify or contact you unless you provide that information yourself, for example when you register for the website, if you email us, if you fill out a form electronically, or otherwise provide personal information during interaction with the website. Personal information is data that can be used to uniquely identify or contact a specific individual. In certain circumstances, we may request, allow or otherwise provide you an opportunity to submit your personally identifiable information with a feature, program, promotion or some other aspect of our Website. If you provide us with personal information through our website, we have taken precautionary steps to help make sure that information you may provide is kept confidential. Stone Mountain Pecan Company and its affiliates may share this personal information with each other and use it consistent with this Privacy Policy. They may also combine it with other information to provide and improve our products, services, content and advertising. You should know however, that we cannot guarantee or warrant the security or privacy of Internet transmissions, as they could be intercepted. **IN ORDER TO PROTECT YOUR PRIVACY, DO NOT EMAIL INFORMATION THAT YOU CONSIDER CONFIDENTIAL.**

Information We Collect:

We collect your information from the following sources:

- Information you give us, such as during registration on the website, website interactions, such as rating products or joining a forum, requesting a quote, customer service operations, surveys, download of a software update, and other website transactions;
- Information available from third parties, including public databases, social medial platforms, or third party partners; and
- Information automatically collected when you visit or use our websites, such as via cookies and device information.

Personal information is information that identifies you or is reasonably linked to you. The personal information we collect may include contact and payment information like your name, email and physical addresses, phone numbers, communication preferences, and other registration information. If you place an order on this site, Stone Mountain

Pecan Company may collect payment information that, in some cases, may constitute Personal Information. When you place an order or request services on behalf of a third-party, we may collect information you provide us such as the name, address, and phone number of the third-party.

When we pick up or deliver a shipment, Stone Mountain Pecan Company may obtain shipping information. Such shipping information includes the sender's and recipient's name, physical address, email address, and telephone number. Shipping information also includes any other information which may be provided which is necessary to us to enable Stone Mountain Pecan Company to access locations that they provide services or information necessary to verify the contents of certain shipments.

Collection and Use of Non-Personal information

We also may collect non-personal information and data in a form that does not permit direct association with any specific individual. We may collect, use, transfer, and disclose non-personal information for any purpose. The following are some examples of non-personal information that we collect and how we may use it: (1) we may collect information such as occupation, language, zip code, area code, unique device identifier, location, and the time zone where an Stone Mountain Pecan Company product is used so that we can better understand customer behavior and improve our products, services, and advertising; and (2) we also may collect information regarding customer activities on our Website and from our other products and services. This information is aggregated and used to help us provide more useful information to our customers and to understand which parts of our Website, products and services are of most interest. Aggregated data is considered non-personal information for the purposes of this Privacy Policy.

If we do combine non-personal information with personal information the combined information will be treated as personal information for as long as it remains combined.

Information from Other Sources

We may receive personal information about you from other sources as well. Examples of these sources are entities that can help us correct or supplement our records, improve the quality or personalization of our service to you, and help prevent or detect fraud. In addition, we may collect information from consumer reporting agencies or other service providers if you obtain certain financial products.

Automated Information Collection

We may receive and store certain types of information when you interact with our websites, emails, and online advertising. Our purpose is to allow the websites to work correctly, to evaluate use of the website, and to support website analytics and marketing campaigns. Some examples include:

- We may collect technical information such as your internet protocol address, your device operating system and browser type, the address of a referring website, if any, and the path you take through our websites.
- We use "cookies" to recognize you as you use or return to our sites. This is done so that we can provide a continuous and more personalized shopping experience for you. A cookie is a small text file that a website or email may save to your browser and store on your hard drive.
- We may also use web beacons. Beacons allow us to know if a certain page was visited, an email was opened, or if ad banners on our website and other sites were effective.

How We Use and/or Disclose Your Information:

- Stone Mountain Pecan Company does not sell or rent your personal information.
- Stone Mountain Pecan Company and its affiliates may use your personal information to provide products and services and support core business functions. These uses include order or service fulfillment, internal business processes, marketing, authentication, loss and fraud prevention, public safety and legal functions.
- Stone Mountain Pecan Company may use the information collected to personalize your interaction with the website, conduct surveys or promotions, respond to any email or request from you, or provide you with information that we believe may be useful to you, such as latest product announcements, important notices, software updates and upcoming events.
- Stone Mountain Pecan Company may use personal information to help us develop, deliver and improve our products, services, content and advertising.

- Stone Mountain Pecan Company may also use personal information for internal purposes such as auditing, data analysis and research to improve Stone Mountain Pecan Company's products, services, and customer communications.
- Stone Mountain Pecan Company may also use personal information to: keep a record of our transactions or communications; to comply with any applicable law, regulation or legal process; protect our rights, the rights of an affiliate or related third party; or, use it to take appropriate legal action, such as enforcement of the Terms of Use.
- We may combine all the information we collect. We may disclose your information within our corporate family of companies.
- Stone Mountain Pecan Company may also use your personal information to contact you through any contact information you have provided in accordance with this Privacy Policy and our Terms of Use.
- If you enter into a sweepstake, contest or similar promotion we may use the information you provide to administer those programs.

Disclosure to Third Parties

At times, Stone Mountain Pecan Company may make certain personal information and/or shipping information available to our strategic partners or affiliates that work with Stone Mountain Pecan Company to provide products and services, or that help Stone Mountain Pecan Company market to customers. Personal information and/or shipping information will only be shared by Stone Mountain Pecan Company to provide or improve our products, services and advertising; it will not be shared with third parties for their marketing purposes or any other use.

The third parties with whom Stone Mountain Pecan Company may share personal information include companies who provide services such as information processing, fulfilling customer orders, delivering products to you, managing and enhancing customer data, providing customer service, assessing your interest in our products and services and conducting customer research or satisfaction surveys. We require our service providers to keep your information secure. In addition, our service providers may not use or disclose personal information for any purpose other than providing the services on our behalf.

The third parties may be located in the United States or anywhere else where Stone Mountain Pecan Company may transact business.

Legal Requirements and Protection of Our Company and Others

We may disclose your information in other special circumstances. These include situations when the sharing is necessary to protect the safety, property, or other rights of Stone Mountain Pecan Company, our customers, our associates, or any other person, or where otherwise required by law. Stone Mountain Pecan Company may provide your personal information in response to a court order, subpoena, search warrant or other legally valid inquiry or order, or to an investigative body in the case of a breach of an agreement or contravention of law, or as otherwise required by applicable law. Stone Mountain Pecan Company may cooperate with law enforcement authorities in investigating and prosecuting activities that are illegal, violate our Terms of Use, or may be harmful to others.

Cookies and Other Technologies

Stone Mountain Pecan Company's website, online services, interactive applications, email messages and advertisements may use a variety of technologies, now and hereafter devised, that automatically collect certain website usage information whenever you visit or interact with the Website. Website usage information may be collected by various methods, including "cookies" and other technologies such as pixel tags, web beacons, mobile device identifiers and embedded scripts. Cookies are small data files that are placed on your Device when it is used to visit our website. We cannot use them to identify you and thus the information collected is treated as nonpersonal information. However, to the extent that Internet Protocol (IP) addresses or similar identifiers are considered personal information by local law, we also treat these identifiers as personal information. Similarly, to the extent that non-personal information is combined with personal information, we treat the combined information as personal information for the purposes of this Privacy Policy. Cookies allow website managers to adapt materials to your computer and include information such as what pages you visited, how often you visited them, what your preferences may be, and they may enable certain features on this Site. Most web browsers accept cookies, but you may be able to

adjust your browser settings to not allow them or to let you know when they are being sent. Your use of some features on this Site may be limited if you disable cookies.

Pixel tags enable us to send email messages in a format our customers can read, and they tell us whether the email has been opened. We may use this information to reduce or eliminate the number or type of messages sent to our customers. Web beacons are small graphic images or other web programming code inserted into a web page or email that count visitors to the Website, monitor how users navigate the Website, count how many emails that were sent are actually opened or count how many particular articles or links were actually viewed. Certain mobile service providers uniquely identify mobile devices and we or our third party service providers may receive such device information if you access the Website through mobile devices. Certain features of our Website may require collection of mobile phone numbers, and we may associate that phone number to mobile device identification information. An embedded script is programming code that is designed to collect information about your interactions with the Website, such as the links you click on. The code is temporarily downloaded onto your Computer from our web server or a third-party service provider, is active only while you are connected to the Website and is deactivated or deleted thereafter.

As is true of most websites, we gather some information automatically and store it in log files. This information includes IP addresses, browser type and language, Internet service provider (ISP), referring and exit pages, operating system, date/time stamp and clickstream data. We use this information to understand and analyze trends, to administer the site, to learn about user behavior on the site, and to gather demographic information about our user base as a whole. Stone Mountain Pecan Company may use this information in our marketing and advertising services.

In some of our email messages, we use a "click-through URL" linked to content on our Website. When customers click one of these URLs, they pass through a separate web server before arriving at the destination page on our Website. We track this click-through data to help us determine interest in particular topics and measure the effectiveness of our customer communications. If you prefer not to be tracked in this way, you should not click text or graphic links in the email messages.

Doing so protects the confidentiality of your personal information while it is transmitted over the Internet.

When you use some of Stone Mountain Pecan Company's products, services or applications or post on an Stone Mountain Pecan Company forum, chat room, or social networking service, if any, the personal information you share

is visible to other users and can be read, collected, or used by them. You are responsible for the personal information you choose to submit in these instances. For example, if you list your name and email address in a forum posting, that Information is public. Please take care when using these features.

Retention of Personal Information

Right to Opt Out.
